**STUDENT'S RIGHT TO CANCEL**

1. You have the right to cancel your agreement for a program of instruction, without any penalty or obligations, through the seventh calendar day after the program start date. After the end of the cancellation period, you also have the right to stop school at any time; and you have the right to receive a pro rata refund if you have completed 60 percent or less of the scheduled days in the payment period of your program through the last day you submitted work or participated in learning activities.

3. Cancellation may occur when the student provides a written notice of cancellation at the following address: 4620 West Magnolia Blvd, Burbank, CA 91505. This can be done by mail, email, or by hand delivery.
  
4. The written notice of cancellation, if sent by mail, is effective when deposited in the mail properly addressed with proper postage.
  
5. The written notice of cancellation need not take any particular form and, however expressed, it is effective if it shows that the student no longer wishes to be bound by the Enrollment Agreement.
  
6. If the Enrollment Agreement is cancelled the school will refund the student any money he/she paid, less the application fee of \$75.00, within 45 days after the notice of cancellation is received.
